

**Chat Agreements Saturday 14.4.2012**  
**Rio + 20 Preparation**  
**IAI**

Cesare, Pedro, Paul.

Cesare spoke the previous day with Bartiria.

It is necessary to remember that the IAI has three objectives for participation in Rio:

1. To contribute with our proposals in the Peoples Summit(...to live well on our planet)
2. To strengthen IAI and its Antennas.
3. To build tools for the Urban Way and to advance the Promoter Committee.

The CC IAI decided to highlight in Rio the participation of the Latin American and Caribbean Antennas, whilst prioritising participation in the Naples Urban Social Forum.

In Rio we will organise the IAI regional meeting, and also organise joint events and of our network.

A unitary meeting of the urban networks (see joint Call) will be held in Rio. This will also involve the Via Campesina, and the networks of the native peoples. Between 500 and 1,000 people will attend, and the proposed date is the morning of the 19th.

On the part of the IAI it is necessary to register two events by the 20/04/12:

- a) Zero Evictions Campaign (drafting of the proposal and coordination under the charge of Cristina A. and Guillermo Rodriguez)
- b) Popular Fund for land and housing (drafting of the proposal and coordination under the charge of Paul)

Using the proposals drawn up by those responsible, Cesare will take charge of the respective registering. Bartiria, member of the methodology committee of the Peoples Summit, looking at what is referred to in the logistics. On the 23rd and 24th April a meeting will take place which will deal with the methodological aspects of the Forum.

Regarding the Zero Evictions workshop, we plan to disseminate the Zero Evictions Guide as a tool for the IAI Antennas and the organisations which stick to the proposal of the Urban and Community Way and from this, to promote a discussion which would allow us to reach an agreement. Cristina Almazán and Guillermo Rodríguez will be responsible for creating a definite proposal.

Regarding the Fund workshop, it is proposed that from the proposal of the IAI a discussion will be promoted which could open a process which would be monitored by a Liaison committee. For which it is necessary to circulate in advance the proposal and to configure a multi dimensional committee, involving both countries and networks, prefiguration of a thematic promoter committee for the Urban and Community Way. Paul will be in charge of making a proposal for this in the shortest time possible. From the point of view of the work of IAI it is also important to put in motion the mechanisms established by the Misereor Project of the Fund presented by IAI, amongst others, to establish a working committee between the Dominican Republic, Mexico and Peru, which would allow us to achieve the organisation of the diffusion and empowerment in each of these countries, to systemize experiences and local advances and to prepare a regional workshop.

Furthermore, CONAM will register two events: On the Energy Rights (together with the energy rights network) and the Water and Drainage rights of the districts.

The commitment of the regional Antennas is, therefore, essential in order to explore all the possibilities (including official delegations, self financing, budget POA 2011-12) to support the participation of the members.

Bartiria is in charge of booking rooms for 20 members, and also finding out the possibility of seeking support from several solidarity bodies.
